

RAJASTHAN PUBLIC SERVICE COMMISSION, AJMER

AMENDED MAIN MERIT LIST PUBLIC RELATION OFFICER

Twenty Six posts of Public Relation Officer for Information and Public Relation Department were advertised by the Commission in their Advertisement No. 02/2019-20 and Corrigendum nos. 02/2019-20, 09/2019-20, 11/2019-20 and 17/2019-20. Interviews for these posts were held on 11-11-2020 and 12-11-2020. Result for 26 posts was earlier declared on 12-11-2020.

Now selection of candidates Rajesh Kumar (Roll No 102393) (ST) (Merit No. 17), Ashok Kumar Meena (Roll No 104136) (ST) (Merit No. 24) and Dharamveer Singh Rathore (Roll No 101903) (GE,EX) (Merit No. 25) has been cancelled by the Commission as they were found ineligible. Candidate Sh. Rajesh Kumar has filed SBCWP No. 4768/2021 in Raj. High Court, in which Hon'ble Court has ordered to keep 01 post reserved for the petitioner.
