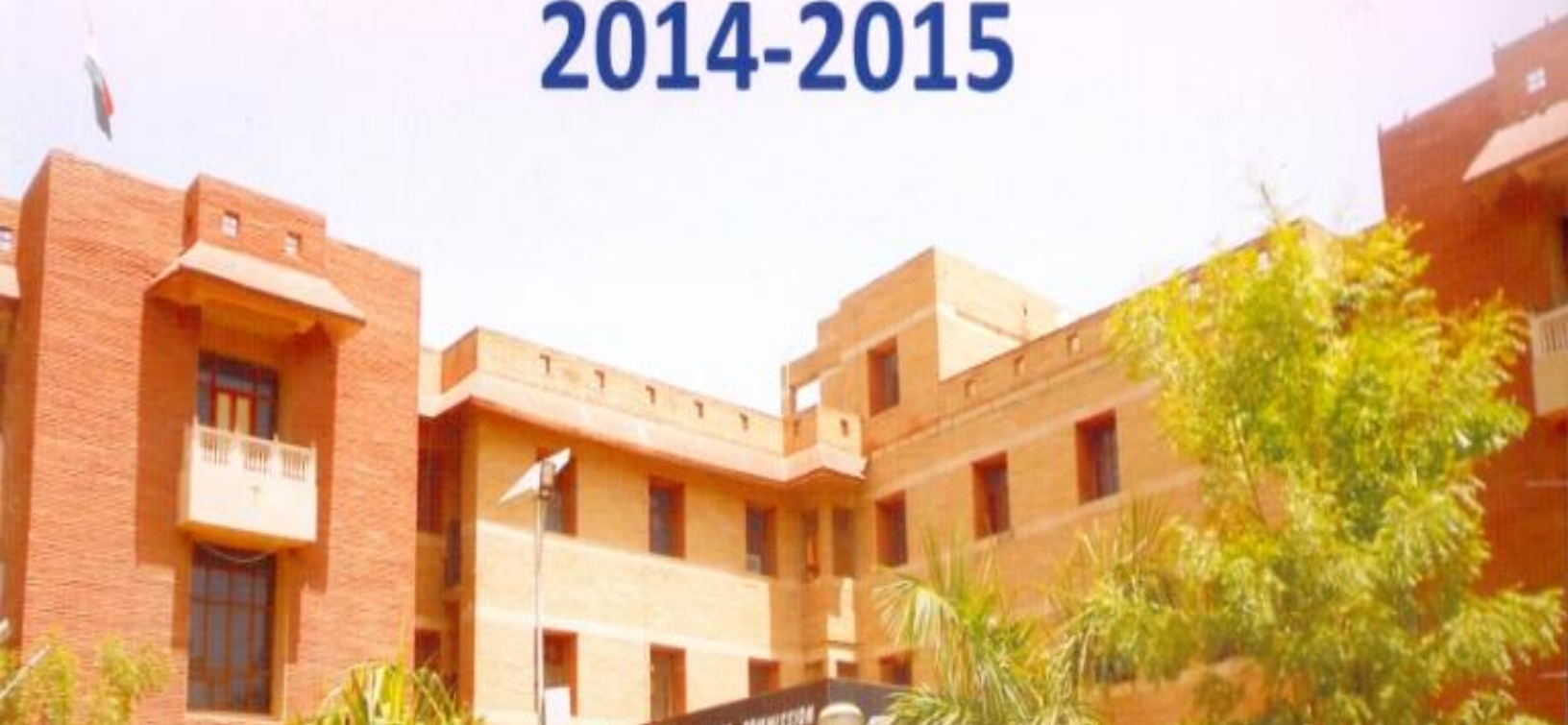

I. THE COMMISSION







The State of Rajasthan was formed as a result of the merger of the erstwhile, princely States situated in Rajputana and Part- 'C' State of Ajmer-Merwara. At the time of formation of Rajasthan the institution of Public Service Commission existed in only three of the twenty-two covenanting States, viz. Jaipur, Jodhpur and Bikaner.

The successor administration after the merger of the princely States promulgated on 16th August, 1949 an ordinance establishing, the Rajasthan Public Service Commission, but it came into existence from 22nd December, 1949 after issuing notification regarding appointment of Hon'ble Chairman and Members of the Commission.

The provisions regarding Public Service Commission for the Union and for the State and appointment & term of office of Members have been laid down in Article 315 & 316 respectively in the Constitution of India.

1.1 The functions of the Commission as laid down in Article 320 of the Constitution of India are given in Appendix-I.

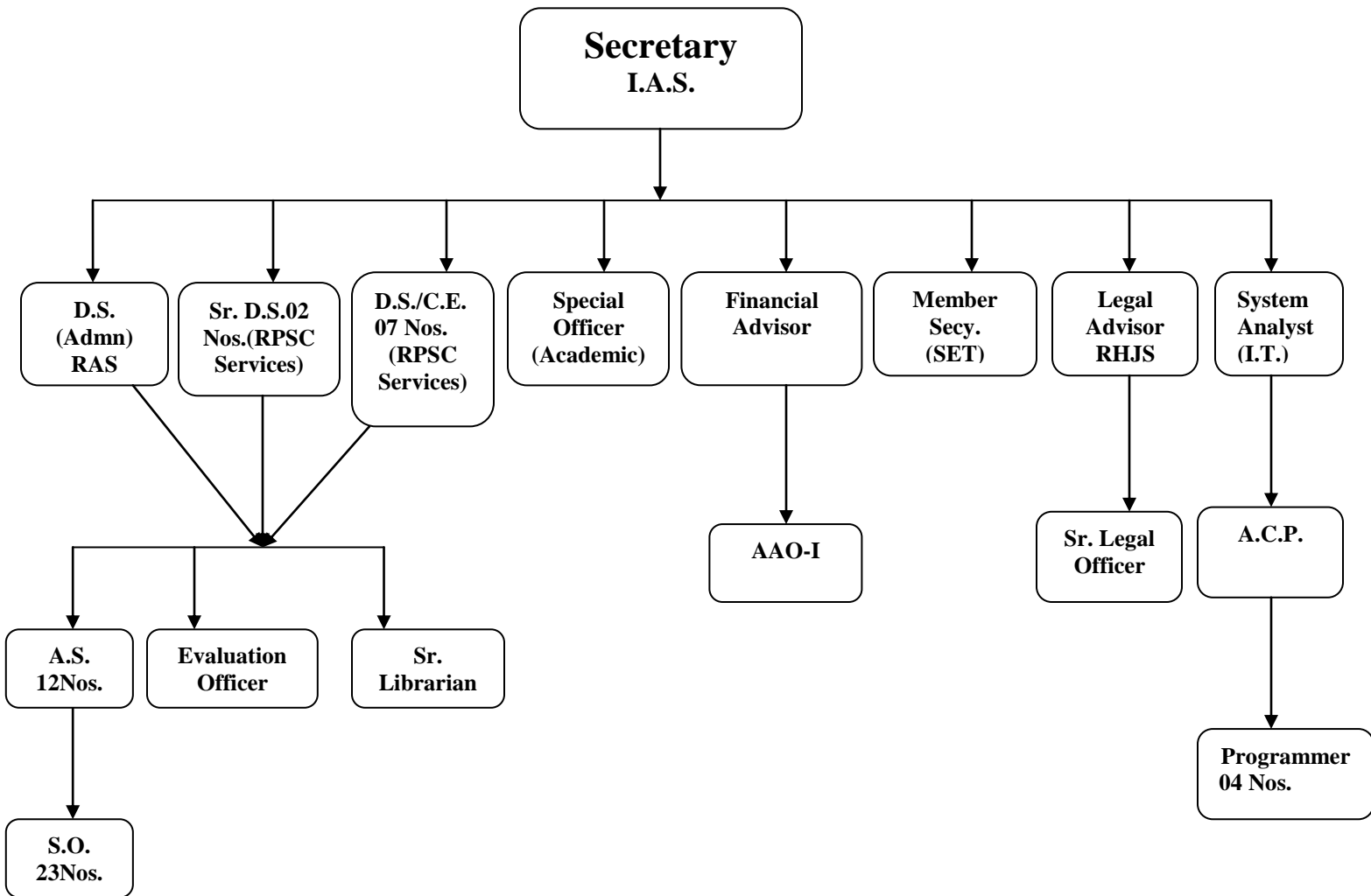

The inauguration of the Guest House building was done by Dr. Jitendra Singh, Hon'ble Minister for Water Resources, Energy,

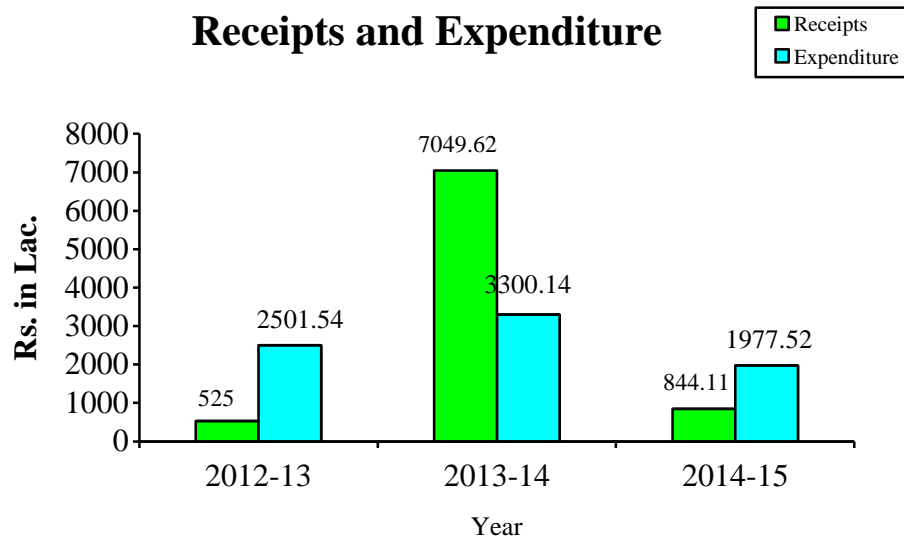

VI. RECRUITMENT

- 6.1 The primary work of the Public Service Commission is to recruit personnel for various service/posts of the State Government. So far as the matter of recruitment of competent candidates for various services is concerned the Public Service Commissions are required to maintain high efficiency, quality, objectivity and transparency. It's a challenge for the Commission to complete the recruitment procedure in a specific time limit. There are so many stages of the recruitment from requisition to recommendation. Number of aspirants are being increased. To meet the increasing number of candidates in various examinations, latest techniques and better management is required. Efforts have been made to reduce the time lag between requisitions to recommendation. Online Application System has been introduced by the Commission.
- 6.2 The recruitment process is completed either by Direct recruitment through Interview alone or Competitive Examination with or without Interview as per the provisions as laid down in the concerning Service Rules. In case, where large number of aspirants apply for the direct recruitment posts, the Commission conducts screening tests to short list the candidates.
- 6.3 **Interview Boards:-** During the year under report, the Commission interviewed 356 (Examination + Interview) candidates for different posts/services by constituting 57 Boards. The number of days on which one Board interviewed the candidates were 57.

6.4 The Commission conducts 18 categories of competitive examinations for recruitment to various posts/services on receipt of requisitions from the Government, which are as follows: -

Hence, at the end of the year 09 requisitions involving 618 posts were pending for notification with the Commission.

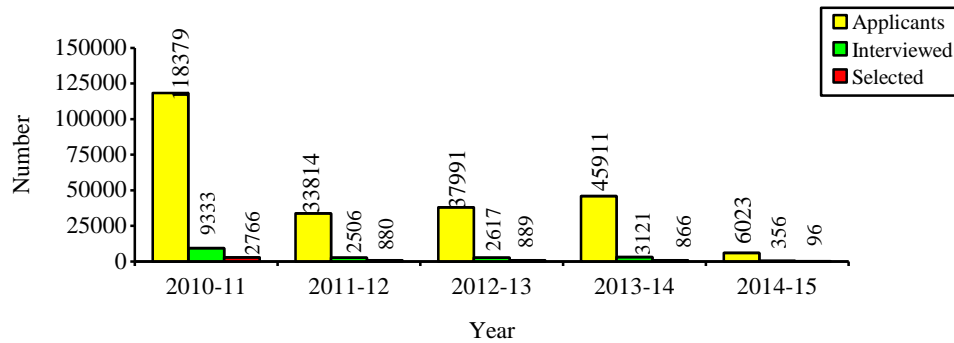
6.9 **Candidates debarred from the Commission’s examinations**

Seven (07) candidates found adopting unfair means in the examinations/ screening tests conducted by the Commission were debarred, during the year under report.

B- By the method of Interview only:

6.10 During the year under report, recruitment was completed in respect of 31 requisitions involving 101 posts. The details of selections done relating to the above requisitions as given in Appendix VII-C (Item Number 1 to 31) are summarized in the following table:

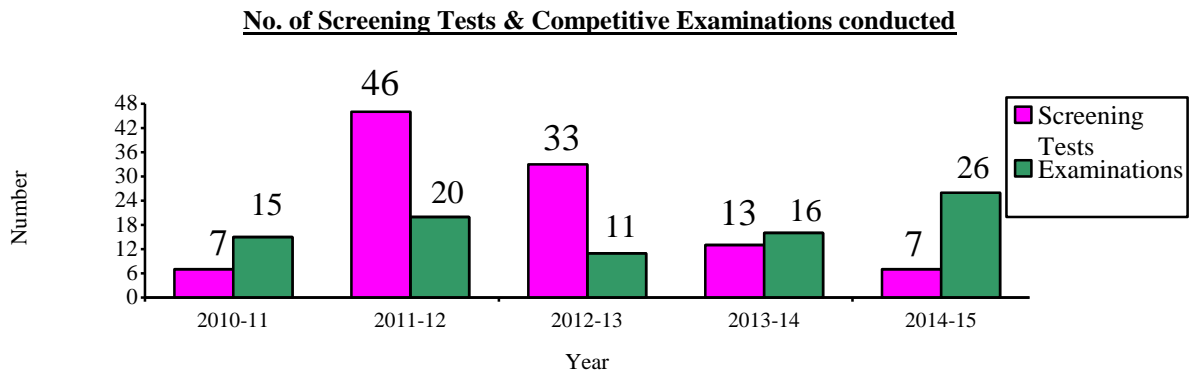

6.11 During the year under report 53 requisitions involving 861 posts were received from the Government. 72 requisitions (including the balance requisition pending notification) involving 1850 posts were notified during the year. 04 requisitions involving 382 posts were returned to the Government due to the reason that the post were outside the purview of the Commission or non-receipt of clarification regarding educational qualifications/experience/category wise distribution, etc for long time. 63 requisitions involving 1181 posts were pending notification at the end of the year. Out of which some requisitions were under query with the Government and some requisitions were under process which are hopefully be notified in the next year.

- 6.13 Department wise/category wise break-up of requisitions advertised against requisitions received during the year 2014-15 is shown in Appendix VII-B.
- 6.14 A list of posts for which requisitions were cancelled after advertisement but before Interview has been given at Appendix VII-F.
- 6.15 During the period under report, the Commission recommended names of 02 candidates from reserve lists. Details of which are given in Appendix VII-H.
- 6.16 **Screening tests:-** The Commission conducted 07 screening tests for short listing the candidates in respect of 608 posts of various departments. The details of screening tests conducted are given in Appendix VII-E.



- 6.17 List of posts advertised but selections remained incomplete during the year under report has been given in Appendix VII – D.
- 6.18 Details of posts for which no candidate found suitable and no any candidate applied are given in Appendix VII-G and VII-I respectively.
- 6.19 Details of posts for which Interviews were fixed but none of the candidates were present has been given in Appendix VII-J.
- 6.20 **State Eligibility Test for Lectureship (S.E.T.):-** The notification for Rajasthan State Eligibility test for lectureship in 29 subjects was issued on 23.10.2013. The last date was 15.11.2013. Due to the State and General elections the examination was not conducted in schedule time. It was held on 27.07.14 after approval from competent authorities of U.G.C. First time a new subject Rajasthani was introduced as 29th subject.
- 6.21 The syllabi and pattern of examination was that of U.G.C. /C.S.I.R., NET examination. The test was held on the Divisional Headquarters. 40054 candidates appeared in all the three papers, with 69%

- attendance. The answer key to all the question papers was put on the website many times and candidates' objection were invited on the answer key till they were satisfied. In questions, the experts' opinion was different but to justify and to kept transparency, the candidates' objection on the key were referred to as many as 13 experts. It is worth mentioning that in 16 subjects no objection was received by the candidates on the answer key.
- 6.22 The result was prepared in November, 2014, but due to non-nomination of Honorable members by University Grants Commission it was delayed. The Meeting of Moderation and Steering Committee was held on 02.02.2015 under the chairmanship of Dr. K.R. Bagaria, Hon'ble Member, R.P.S.C. Ajmer. Top 15% candidates (for each subject and prescribed category) from the merit list were prepared, subject-wise and category-wise using aggregate marks of all the three papers secured by such candidate. It is heartening to mention that all the nominated members of Moderation and Steering Committee were present in the Meeting and they appreciated the process adopted by R.P.S.C. for putting answer key on website and inviting candidate's objection online. The members also noted on record that in 16 subjects after key validation no objections were raised by the candidates.
- 6.23 The other important issue which was brought to the notice of members was that about 2000 students who have qualified SET-12 have not taken their SET-certificate in spite of repeated reminders. This is due to either they have already qualified NET/SET or could not qualify in the post-graduate examination. The members were of opinion that reserve list may be prepared in future so that candidates after top 15% may be considered against such vacancy. Efforts were made by the Commission to include SET equivalent to NET for the eligibility in Ph.D. The M.D.S. University authorities agreed and this decision is in the larger interest of SET qualified students of Rajasthan. Now they have not to appear in RET examination for Ph.D.
- 6.24 Looking to the past experience and vacancy advertised by the Government for the post of Lectureship, it was decided to conduct counseling of all qualified SET candidates. The counseling has been started from 16th March, 2015 and likely to continue till last week of April, 2015. The documents of all the candidates will be checked by the officers not below the rank of Assistant Secretary and will be returned after verification. Everyday 250-300 candidates are invited and it is worth mentioning that more than 90% - 95% candidates are responding every day the R.P.S.C. & Post Office has also made extra

arrangements for postal orders and other accessories and put up 4 counters with 4 members on each counseling table.

VII. REFORMS IN THE RECRUITMENT PROCESS

- 7.1. **Review, Revision and Redrafting of syllabi:-** Review, revision and redrafting of syllabi of various subjects prescribed for various competitive examinations and screening tests conducted by the Commission, have become a regular process. Eminent subject-experts were invited to participate in the workshops/seminars organized by the Commission, for this purpose.

7.2. During the year under report, the syllabi for the following categories of the posts/subjects were reviewed or new framed by the Commission by assigning the work to eminent subject experts :-

VIII. RESERVATION FOR SC, ST, OBC, S.B.C., P.D. AND WOMAN CANDIDATES

(a) Recruitment by examination with or without interview :

8.1. Reservation of 16, 12, 21 and 1 *per cent* of posts has been fixed for candidates belonging to Scheduled Caste, Scheduled Tribe, Other Backward Class and Special Backward Class respectively (for OBC's w.e.f. 28/09/93) (For SBC's w.e.f. 25/08/2009). 30% reservation of vacancies has been fixed for woman candidates in direct recruitment. Reservation of vacancies for woman candidates is to be adjusted proportionately in the respective category to which they belong and the reservation shall be treated as horizontal (for woman candidates vide Notification dated 7/06/99 w.e.f. 01/04/99). Similarly, 3 *per cent* reservation of vacancies has been fixed for Physically Disabled candidates in direct recruitment, which shall be treated as horizontal and adjusted from among all categories (reservation for Physically Disabled candidates fixed vide Notification dated 22-09-2000 w.e.f. 22-09-2000.)

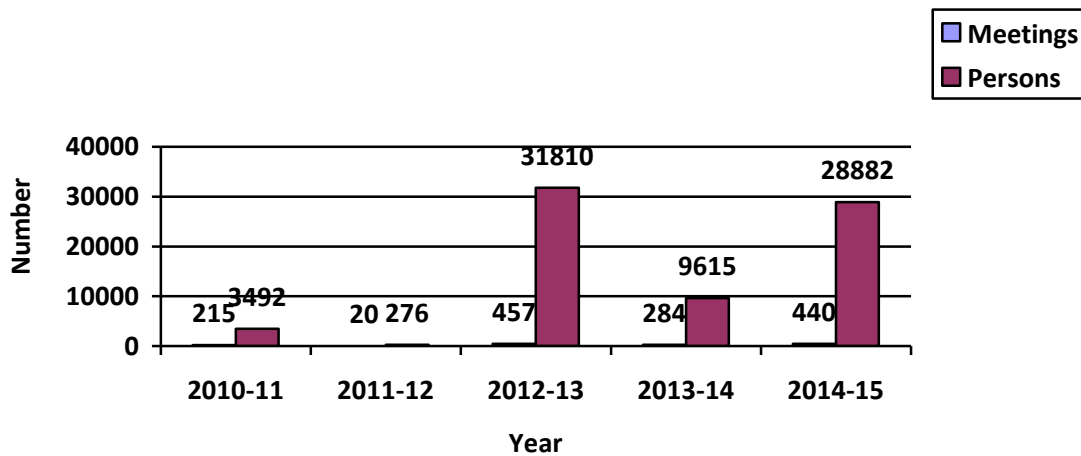

**IX. DEPARTMENTAL PROMOTION COMMITTEES
AND OTHER COMMITTEES**

- 9.1. The Commission held meetings of Departmental Promotion Committees on 240 occasions to regularize *ad hoc*/temporary appointments of posts involving 21322 persons, of which large number of cases pertained to the Primary & Secondary Education Department (132), Agriculture Department/ Medical & Health Department/Ayurved Department (12) and Home Department (13).
- 9.2. The meetings of Review Committees were also held on 119 occasions for regularizing 5638 persons, of which large number of cases pertained to the Primary and Secondary Education Department (69), Home Department (6) and Medical & Health Department/Ayurved Department (08).
- 9.3. Meetings of Screening Committees were also held on 81 occasions for regularizing 1922 persons.

X. EXTENSION IN THE TERM OF TEMPORARY APPOINTMENTS

- 10.1. A mention was made in the previous year's report in regard to the cases of *ad hoc*/temporary appointments referred to the Commission for obtaining their concurrence to the extension of their terms of temporary appointments. The Government has also been apprised of the alarming position in regard to the cases of *ad hoc*/temporary appointments lasting over 5 years and in some cases even 10 years with the intention that the Government might take expeditious steps for regularizing those cases. The position of *ad hoc*/temporary appointments still remained unchanged, in spite of the fact that many Departmental Promotion Committees meetings were held during the year for making selection by promotion. An illustrative list of long outstanding cases of such *ad hoc*/temporary appointments is being given again in Appendix IX.
- 10.2 During the period under report, the Commission accorded their concurrence for extension in the terms of temporary appointments in respect of 355 persons appointed against the post to be filled against Direct recruitment quota as per the details given in Appendix-XI.
- 10.3 The number of such *ad hoc*/temporary appointees were 599 during the year, while it was 319 in the previous year. The Government will take appropriate action in order to put a check on such appointments.
- 10.4 During the period under report, the Commission accorded their concurrence for extension in the terms of temporary appointments in respect of 244 persons appointed against the posts to be filled by Promotion quota as per the details given in Appendix-X.
- 10.5 Some of the appointing authorities failed to furnish complete information in the prescribed proforma while referring the cases of urgent/temporary appointments to the Commission for obtaining their concurrence. The result is that the Commission had to make a back reference before considering the case for conveying their concurrence. During the year under report two incomplete references, involving (digit is not clear) persons appointed against promotion quota posts were referred to the Commission. The list available in Appendix-XII.

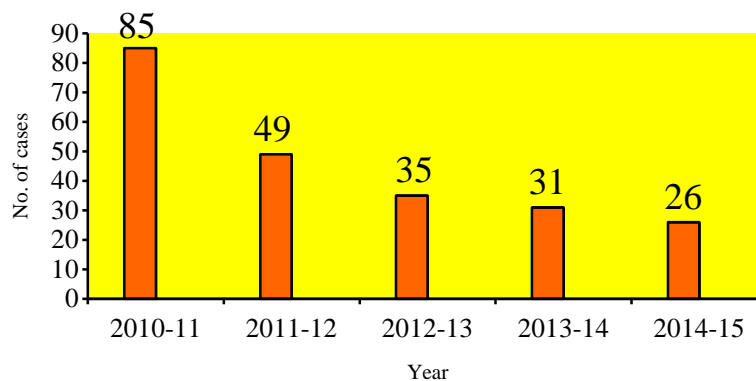
XI. IRREGULAR APPOINTMENTS

XII. DISCIPLINARY CASES AND APPEALS

- 12.1. **Disciplinary cases** :- 08 cases were pending with the Commission on 01-4-2014. During the year under report, the Commission received 51 new cases, making a total of 59 cases; the Commission tendered their advice on 26 cases i.e. on 05 cases received in previous year's and on 21 cases received in the current year.
- 12.2 Out of 08 cases of the previous year's, advice tendered on 05 cases, 01 case was under query with the Government and 02 cases were under consideration of the Commission.
- 12.3 Out of 51 cases of the current year, advice tendered on 21 cases, 01 case was under query with the Government and 29 cases were under consideration of the Commission.
- 12.4 Hence, total number of cases on which advice tendered by the Commission is 26.
- 12.5 At the close of the year, there were 30 cases pending with the Commission, of which 01 case was under clarification with the Government and 29 cases was under consideration of the Commission.

Advice tendered on D.E. cases

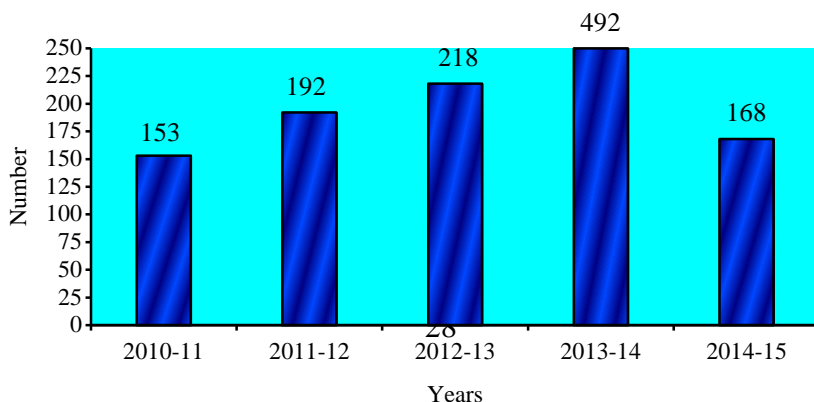


- 12.6 **Appeal/Review D.E. Cases** :- During the year under report, no any case of Review D.E. was received by the Commission. No case of Appeal was received by the Commission.
- 12.7 **Litigations/Writs** :- During the year under report, 804 cases in addition to 3023 cases of previous years of Civil suits/Complaints/ Writ petitions/appeals/D.B. special appeals/S.L.P. filed in the Civil Courts/High Court/Service Tribunal/Supreme Court/State Consumer Protection Commission/ District Consumer Forum etc. were pending, thus, making a total of 3827 cases. During the period under review, the number of cases decided by the various courts was 1150. Thus, in all, 2677 cases were awaiting decision in the various Courts.

XIII. SERVICE RULES

- 13.1 Draft Amendments to **168** Rules/Schedules relating to various Services were referred to the Commission for their comments which were conveyed in all Draft Amendments. Details thereof have been given in Appendix-XIII.
- 13.2 During the year under Report the Commission also examined and dealt with the Draft of **07** New Rules. Details thereof have been given in Appendix- XIV.
- 13.3 During the year under report the Government has promulgated New Service Rules and amendments in **13** Service Rules/Regulations as shown in Appendix-XV.
- 13.4 During the year under Report the Commission have received **two** cases of Compassionate Appointment of Dependents of Deceased Government Servants. The Commission vide their letter dated 20-08-2014 and 01-09-2014 respectively sought certain information/documents from the Home (Group-1) department but the reply was awaited till the end of the year under report. Details of these cases are shown in Appendix-XVI.
- 13.5 During the year under Report Commission received **one** case of Compassionate Appointment of Dependents of Deceased/Permanently incapacitated Armed Forces Service Personnel/Para Military Personnel. This case was examined under the relevant Rules and the Government in the Revenue (Group-1) Department vide their letter dated 28-11-2014 informed to the Registrar, Board of Revenue, Ajmer that the post of Naib Tehsildar having G.P. No. 12 carrying G.P. 4200/- does not come under the category of Compassionate Appointment as per the existing Service Rules. Hence, appointment may be given on the post having G.P. No. 11 and copy of the letter was forwarded to this office, in reference to this office letter dated 12-02-2014 for information, therefore, the Commission vide their letter dated 09-01-2015 returned the case in original to the Revenue Board for their further necessary action. Details of this case has shown in Appendix-XVII.
- 13.6 Besides the above, one case was received from Finance (Excise) Department for the comments of the Commission regarding fulfillment of 12.5% posts of Excise Inspector Grade-II from the quota of ministerial staff in accordance with the rules of Rajasthan Excise Subordinate (General Branch) Service Rules, 1974. After examining the case, comments of the Commission were conveyed to the Government vide this office letter dated 19-08-2014.

APPENDICES

APPENDIX I
Functions of the Commission

The functions exercised by the Rajasthan Public Service Commission are laid down in Article 320 of the Constitution of India.

The Public Service Commission shall be consulted:-

(a) On all matters relating to methods of recruitment to civil services and for civil posts;

(b) On the principles to be followed in making appointments to civil service and posts and in making promotions and transfers from one service to another and on the suitability of candidates for such appointments, promotions or transfers;

(c) On all disciplinary matters affecting a person serving under State Government in civil capacity, including memorials or petitions relating to such matters;

(d) On any claim by or in respect of a person who is serving or has served under the State Government, in a civil capacity that any costs incurred by him in defending legal proceeding instituted against him in respect of acts done or purporting to be done in the execution of his duty should be paid out of the Consolidated Fund of the State;

(e) On any claim for the award of a pension in respect of injuries sustained by a person while serving under the State Government in a civil capacity and any question as to the amount of any such award; and

(f) Any other matter referred to them by the Government.

It shall not be necessary for the Commission to be consulted in matters relating to methods of recruitment to Civil Services and Posts, or the principles to be followed in making appointments to such posts, or the suitability of the candidates for such appointments :-

Unless otherwise provided in the relevant Service Rules for recruitment to any post in a Service, when the appointment is to be made to any post -

- 1 in Ministerial Service, or
- 2 in Subordinate Service or State Service whether technical or non-technical starting with an initial Grade Pay of “Rs. 3600/- or less per month” as per R.P.S.C. (Limitation of Functions) Regulations, 1951.
