आर.ए.एस. परीक्षा-2023 में प्रोविजनल अभ्यर्थियों से वांछित दस्तावेज के संबंध में

उक्त निर्धारित दिनांक को अभ्यर्थी द्वारा वांछित दस्तावेजों की पूर्ति नहीं किये जाने पर अभ्यर्थी की पात्रता रद्द करते हुए चयन निरस्त कर दिया जायेगा, जिसकी समस्त जिम्मेदारी स्वयं अभ्यर्थी की होगी। उक्त दिनांक के पश्चात कोई पत्राचार स्वीकार नहीं किया जायेगा।
